## TO A MORE PERFECT UNION USA I 1 HOUR 30 MINUTES



To a More Perfect Union: U.S. v Windsor is a feature-length documentary that tells a story of love, marriage, and a fight for equality. The film chronicles two unlikely heroes: octogenarian Edie Windsor and her attorney, Roberta Kaplan, on their quest for justice. Edie had been forced to pay a huge estate tax bill upon the death of her spouse because the federal government denied federal benefits to same-sex couples and Edie's spouse was a woman. Deeply offended by this lack of recognition of her more than forty-year relationship with the love of her life, Edie decided to sue the

United States government – and won. Windsor and Kaplan's legal and personal journeys are told in their own words, and through interviews with other members of the legal team, movement activists, legal analysts, well-known supporters, and opponents. Beyond the story of this pivotal case in the marriage equality movement and the stories behind it, the film also tells our story as a people, as a culture, and as citizens with equal rights.

## THE DIVINE ORDER SWITZERLAND I 1 HOUR 36 MINUTES



This film, winner of an Audience Award for Best Narrative Film at the Tribeca Film Festival, is set in Switzerland in 1971 where women were denied the right to vote. When unassuming housewife Nora is forbidden by her husband to take a part-time job, her frustration leads her to become the poster child of her town's suffragette movement. Despite many obstacles and a possible end to her marriage, she refuses to back down and convinces women in her village to go on strike. Uplifting and crowd-pleasing, this captivating film is a time-capsule that could not be more timely.
